- (5) No of Government Post Vacant & Those in rural/ difficult area. :- not updated
- (6) No of dental Surgeons registered with the Employment exchange :- Nil
- (7) dental Surgeon Population Ratio in the state :- State population of 60253000 as per 2001 census. Population of Indore town where Dental College is proposed 2465827

- (8) How the establishment of the college Would resolve the problem of deficiencies of qualified dental personnel in the state and improve the availability of such dental manpower in the State :- By increasing qualified dental personnel in the state
- (9) The restrictions imposed by the State Government if any; On students who are not domiciled in the state from obtaining admissions in the State be specified :-Essentially to domicile Of MP 15% seats reserved for ALL India Quota, one seat reserved for Govt; of India Nominee.
- (10) Full Justification for opening of the proposed college :-For opening of the proposed dental college the Applicant is a registered trust possessing 5 acre Land, hospital Building to Accommodate 100 beds with adequate planning & funds for future development in stipulated time frame as per DCI requirements. The Institution has submitted application for grant of affiliation to Devi Ahilya University Indore.
- (11) Dental Surgeon Patient Ratio proposed to be achieved :- not updated
- (12) Copy of the Inspection Report :- in connection with the Inspection carrier out by the State Govern ment for grant of permission for setting up a new Dental College is to be attached :- Attached

Mayank Welfare Society, Indore (Name of the applicant) Trust/Society) has applied for establishment of Dental College by the name of Index institute of Dental Science at Indore. On careful consideration of the proposal, the Government of Madhya Pradesh has decided to issue an Essentiality Certificate to the applicant for the establishment of a Dental College with 100 (no.of seats)

It is certified that:-

- (a) The applicant owns and manages a 500 bedded hospital
OR

Where no Medical College is available in the proximity of the proposed Dental College, the proposed Dental College get itself tied up for at least 20 years with a Govt.General Hospital which is having at least 100 beds and which is located within 10 KM by road of the proposed Dental College till they have their own hospital in the same premises. It shall be the duty of the applicant to produce evidence that the infrastructure facilities such as teaching ,pre-clinical, para - clinical and allied medical sciences are owned by the proposed Dental College itself.

The Trust has obtained letter of permission for training of Dental Students at Index Hospital and Research Centre, Indore own Hospital

- (b) The applicant owns and manages a Dental Hospital of -----
---- -beds.
- (c) It is desirable to establish a Dental College on the public interest
- (d) Establishment of a Dental College at Indore by Mayank Welfare Society, Indore (the name of Society/Trust)is feasible;
- (e) Minimum 30 OPD Dental patients per day are available to begin with.

It is certified that the trust has to complete all requirements and parameters formulated by DCI and obtain permission from Govt.of India to start the institution within a period of 2 years from the date of issue of this revised certificate and start the institution,otherwise after 2 years of the date of issue of the revised desirability & feasibility certificate, it will be treated as cancelled automatically.

It is also certified that institution has submitted the undertaking that the premises to run the dental course which is under construction will be completed before DCI inspection and other deficiencies marked will also be rectified .

The Desirability & Feasibility certificate is issued with the condition that the society shall fulfill the requirements/norms specified by Dental Council of India to start the Dental College.

It is further certified that in case the applicant fails to create infrastructure for the dental college as per Dental Council of India's norms, fresh admissions are stopped by the Dental Council of India, the State Government shall take over the responsibility of the students already admitted in the college with the permission of the Central Government.
